



BRED-BY EXHIBITOR CLASS: This Class shall be for dogs that are: Six months of age or older as of the first day of the show; Not Champions of record on the date of closing of entries for the show; Individually registered with the American Kennel Club as of the date of closing of entries for the show; Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which a dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

# NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES VETERAN CLASSES (FOR DOGS & BITCHES)

\*Chapter 11, Section 8 "Rules Applying to Dog Shows" provide that a neutered male or spayed bitch may be entered as a veteran. Winners of the above classes are eligible to compete in Best of Breed.

#### BEST OF BREED COMPETITION ~ BEST PUPPY

**BEST OF BREED CLASS:** "Effective for all shows held on or after July 1, 1980, dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show, but whose championship are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Superintendent or Show Secretary at least one half hour prior to the start of any regular conformation judging at the show."

#### SPECIAL ATTRACTION.....(All Specialty Events)

BEST PUPPY-During the course of Regular judging, the assigned judge will select a Best Puppy from the Class winners of the 6 mos. and under 9 mos. and the 9 mos. and under 12 mos. Classes. This will be done after the Best of Breed Competition judging unless the Best Puppy award is automatic. Example: An entry from the Puppy Classes is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in a Puppy Class are eligible for Best Puppy Competition. If the first place winner is not present, the second place winner may not compete.
